#### SCHEDULE FOR RECEIPT OF ONLINE REGISTRATIONS

Normal Fee Rs. 1200/- per student

23-10-2024 to 04-12-2024

Double Fee Rs. 2400/- per student

05-12-2024 to 16-12-2024

After 16-12-2024, Rs.1200/- per month per student will be charged as per notification No.KIU-CE-12(2)/2015/271 dated 2<sup>nd</sup> April, 2019.

- 1. Registration Fee shall be deposited at any KCBL Bank Branch by using online generated fee challan available at web portal. Manual Bank Challans will not be considered.
- 2. After fee submission, Fee Challan (Examination Section Copy) and copy of SSC marks sheet must be uploaded in above portal.
- 3. Board to Board transfer students registering in HSSC-II, shall upload scanned copy of NOC and copy of HSSC-I marks sheet, in addition to the above documents.
- 4. Hard Copies of Fee Paid Voucher, List of Students and Original NOC & copy of SSC & HSSC-I Marks Sheet (board transfer cases) must be submitted to the KIU Examination Section within 7 days after last date of submission of registration forms/fee.
- 2. Tutorial/ Instructions for online submission of Registration Return is available at the web portal mentioned above.
- 3. The KIU reserves the rights to cancel the registration of a student at any stage, if the particulars provided by the candidates/institutions found incorrect or have concealed the facts.
- 4. The Head of Institution shall be personally and legally responsible for communication of complete and accurate particulars of the students, i.e. spellings of name, parentage, date of birth, CNIC number e.t.c as these particulars shall be treated as full and final; and will accordingly be exhibited on all documents/certificates issued by the KIU Examination Section.
